8/19 – Fifteen pedestrian tracks observed in sea turtle nest closure 1.0 mi E Ramp 55.

8/19 – An ORV entered the NH10/NH17/NH20 closure at 0.3 mi E Ramp 45, from the east driving below the signs and under the three nests and then around and above NH10 and then between NH10 and the other two nests and under NH17/NH20 and then exited in the direction it had entered.

8/19 – Two pedestrian tracks observed in sea turtle nest closure 0.1 mi S of Ramp 30.

8/19 – Dog tracks observed in sea turtle nest closure 0.7 mi S Ramp 34.

8/19 – One set of pedestrian tracks observed in sea turtle nest closure 0.1 mi N of Ramp 38.

8/19 – Four pedestrian tracks observed in sea turtle nest closure 2.8 mi S of Ramp 38.

8/23 – One set of pedestrian tracks observed in sea turtle nest closure 0.1 mi S of Ramp 38.
